

2023 - 2032 Residential Heating and Cooling Equipment Certificate for Qualified Energy Property Tax Credits

On August 16, 2022,, President Biden signed into law the Inflation Reduction Act of 2022 which reinstates/ extends the Section 25C tax credit that expired on December 31, 2020. The credits are reinstated and applicable for equipment installed between January 1, 2023 and December 31, 2032. Branded heating and cooling products, manufactured by Nortek Global HVAC, LLC, certifies that the models or systems listed on the following page, if placed in service after January 1, 2023 and before January 1, 2033 in a homeowners primary residence, meet the criteria of “Qualified Energy Property” as set forth by Section 25C of the Internal Revenue Code. The maximum amount an eligible homeowner may receive in federal tax credits for purchasing and installing qualifying products, whether those purchases are in the form of upgraded windows, insulation, HVAC equipment or other eligible improvements, is 30% of the installed cost, up to \$2000.
